





ARTICLE 1

UNION RECOGNITION

Section 1 – Union Recognition

The employer recognizes the Greater Las Vegas, Nevada Area Local American Postal Workers Union, AFL-CIO, hereafter referred to in this memorandum of understanding as the union or unions, as the bargaining representative of all employees in the clerk, motor vehicle, and maintenance crafts.
